Subject: Ohio ABAWD Waiver Request for FY 2019?

Hi Sandra, Scott, and Sheena,

As we move closer to October 1, I want to flag Ohio as the last MW state we expect to submit an ABAWD waiver for new FY. Could you please check with Ohio and ask whether they will be submitting a request for this FY? If so, we encourage them to submit the request as soon as they can (we normally ask States to send them in at least a couple months before the implementation date.) Given our current clearance process, the sooner the better. In terms of the other MW states, here is where we stand:

- MN: We have the request for Oct 1., and are processing.
- OH: Current waiver expires Sept. 30. – extension request not yet received.
- IL: Current waiver expires Dec. 31. – extension request not yet received.
- MI: Current waiver expires Dec. 31.—extension request not yet received.
- WI: No waiver
- IN: No waiver
