Dear Ms.Brathwaite:

Rhode Island is requesting to modify and extend the waiver numbered 970051 that exempts certain individuals from the requirements of the "Able Bodied Adults Without Dependent" (ABAWDS) regulations.

According to the Bureau of Labor Statistics (BLS) current population survey (CPS), the unemployment rate for Rhode Island rose 0.1 percentage points in April 2012 to 11.2%, which depicts 3.1% higher than the national average unemployment rate of 8.1%.

Based on Rhode Island's existing unemployment rate of 11.2%, the ABAWD population continues to face extraordinary challenges in finding and securing employment at this time. This request to extend the current waiver would apply to all cities and towns throughout the State of Rhode Island.

With this in mind, the State is requesting this 12 month waiver to be effective October 1, 2012 through September 30, 2013.

WAIVER REQUEST

Section 6 (o) of the SNAP Act, as amended by Section 824 of the Personal Responsibility and Work Opportunity Reconciliation Act (PRWORA) of 1996, P.L. 104-193.
4. **Secondary regulation citation, if any:**
7 CFR 273.24 (f)(3)(iii)

7. **Regulatory requirements:**
Under 7 CFR 273.24(b) individuals are not eligible to participate in the SNAP Program as a member of any household if, during the preceding 36-month period, the individual received SNAP benefits for not less than 3 months (consecutive or otherwise), during which the individual did not work 20 hours or more per week, averaged monthly; participate in and comply with the requirements of a work program for 20 hours or more per week; or participate in and comply with requirements of a program under Section 20 or a comparable program established by the State.

Under 7 CFR 273.24(f), upon the request of a State agency, the Food and Nutrition Service (FNS) may waive the applicability of the above provision for any group of individuals in the State if the FNS makes a determination that the area in which the individuals reside has an unemployment rate of over 10 percent, or does not have a sufficient number of jobs to provide employment for the individuals.
8. **Proposed procedures:**
Rhode Island is requesting a modification and extension of its existing waivers to exempt residents residing in the entire State from the work requirements of 7 CFR 273.24 due to having insufficient jobs based on the U.S. Department of Labor data that the State qualifies for extended unemployment benefits.

26 USC 3304 (Public Law 102-318) allows States the option of providing an additional alternative trigger for the extended benefits program, based on the State's

seasonally adjusted total unemployment rate (TUR) for the most recent three months reaching at least: (1) 10% percent; and (2) 95.6 percent of such TUR for the corresponding three-month periods ending in either or both of the two preceding calendar years.

9. Justification for request:

Rhode Island is continuing to experience state-wide high unemployment conditions and does not have a sufficient number of jobs to provide employment for individuals. Based on this fact, we are seeking the waiver to exempt residents from work requirements.

Rhode Island has experienced a consecutive three (3) year average unemployment rate of 11.0%. This request to exempt residents residing in the entire State from the work requirements of 7 CFR 273.24 is also due to having insufficient jobs and the fact that Rhode Island's **current unemployment rate of 11.2%** is well above the national average of 8.3%. Under 7 CFR 273.24(f), the state may request a waiver if the area in which an individual resides has an unemployment rate of over 8.1%.

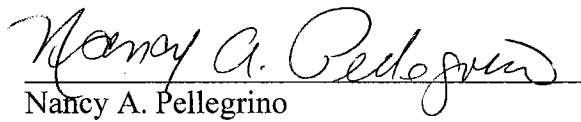
10. Anticipated implementation date and time period for which waiver is needed:

The State is requesting a one-year waiver from October 1, 2012 through September 30, 2013.
